

# Application for a 5 MHz Notice of Variation (NoV) to an Amateur Radio (Full) Licence

This application form is for the use of holders of the Amateur Radio (Full) Licence, who wish to request a Notice of Variation (NoV) which will permit them to operate on certain “spot” frequencies in the 5 MHz range for a limited period. The NoV cannot be issued to a licence held on behalf of a club. The NoV shall only vary an applicant’s licence for a temporary period and use of the spot frequencies will not be permitted under CEPT Recommendation T/R 61-01 outside the UK or its territorial waters.

The applicant must also understand that by completing and submitting this application he/she will be required to operate totally within the 3 kHz bandwidth channels specified in the Notice of variation. The applicant will also be invited to operate the station in accordance with the “5 MHz Operating Procedure” available at <http://www.rsgb.org/spectrumforum/hf/operating.php> , on a voluntary basis.

Please complete all fields clearly in black using block capitals. If you do not have a mobile number write “NONE”. It is a condition of issuing the NoV that the licensee must be contactable via a telephone located at or close to the station. This is to facilitate the issue of instant close-down instructions by a person authorised under the Secretary of State, or any government or military official.
