

WIRELESS TELEGRAPHY ACT 2006

VARIATION NUMBER 5 DATED 20 OCTOBER 2009

TO LICENCE GRANTED TO BBC FREE TO VIEW LIMITED (“THE LICENSEE”) UNDER SECTION 8(1) OF THE WIRELESS TELEGRAPHY ACT 2006 (“THE LICENCE”) AUTHORISING THE ESTABLISHMENT AND USE OF STATIONS DESCRIBED IN THE SCHEDULES TO THE LICENCE FOR THE TRANSMISSION OF BROADCASTING SERVICES IN ACCORDANCE WITH THE TERMS, PROVISIONS AND LIMITATIONS OF THE LICENCE DATED 6 JULY 2007 AS AMENDED BY VARIATION NUMBER 1 DATED 10 OCTOBER 2008, VARIATION NUMBER 2 DATED 15 APRIL 2009, VARIATION NUMBER 3 DATED 2 JUNE 2009 AND VARIATION NUMBER 4 DATED 5 AUGUST 2009

WHEREAS

- A. Ofcom has notified the Licensee that Ofcom intends to change the holding of Wireless Telegraphy Act licences for television broadcasting from digital switchover so that the licences are held by the relevant multiplex operators and not the transmission companies;
- B. The Licence therefore needs to be varied to take account of digital switchover in the Granada region and in accordance with Schedule 1 paragraphs 6 and 7(1) of the Wireless Telegraphy Act 2006, Ofcom has given the Licensee an opportunity to make representations on the proposed variation.

NOW THEREFORE the Licence shall be varied in the following manner:

1. In the Schedule to the Licence, by inserting the reference to the following frequency assignments for television broadcasting from 2 December 2009:
